7/19/2023	Web	I work at a business right at the now closed down exit 31 on Rt 50 (not in the Jamal shopping centre but behind it, [Address Redacted]) and live on Kent Island. The weekend closures have so far (one weekend in) not been terrible for me on Thursday through Saturday when I work across the bridge, however, if there is a major back up, if say the 3rd lane isn't opened due to weather, I will have to backtrack at least a mile or so to get into that traffic. Is there no concession for those of us who have to work on this road and commute to KI? I am also perplexed by the concern shown for a small strip of road that gets blocked on the Western Shore but yet nothing is done about the gridlock of an entire community on Kent Island and Grasonville. The locals have had to resign themselves to not going anywhere during certain hours on the weekends. I think we ought to be shown the same curtesy shown to the residents on the access roads leading up to the bay bridge - far more people are impacted on the east side! 		The Southern Maryland Active Recreation and Transport Alliance (SMART) strongly urges Maryland Transportation Authority to provide safe bicycle facilities on the new Chesapeake Bay Crossing Bridge and associated transit corridor. A dedicated bicycle/pedestrian lane separated from vehicular traffic would prove to be popular for recreational and tourist use – acting itself as a tourist draw. The Authority should consider construction of a barrier between traffic and pedestrians and bicyclists to be high enough to cut risk of foreign objects flying into the dedicated lane, cut traffic wind rush there and reduce traffic noise to create an incredible bay experience.
